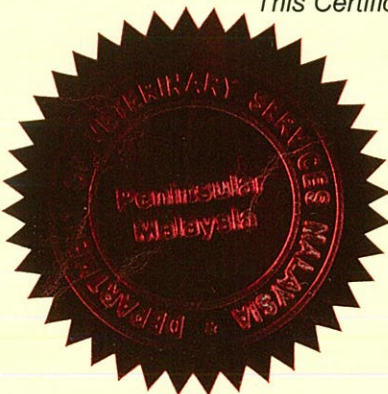

**CONDITIONS FOR USE AND WITHDRAWAL OF
"VETERINARY HEALTH MARK (VHM)" LOGO AND CERTIFICATE**

Conditions for Use of VHM Logo

All accredited plants are allowed to use the VHM logo subject to the following conditions:

1. The logo can be imprinted on labels / packaging of approved products only. Samples of logo - imprinted on packaging either in photographic or normal-size form should be submitted to DVS as evidence of use.
2. The use of the VHM logo is only permitted for products and premises that have been approved by the Department of Veterinary Services, Malaysia.
3. The management of approved establishments agrees to give access to DVS staffs for purpose of inspection, surveillance and compliance audit, sampling for laboratory testing and other relevant veterinary inspection tasks.
4. Any changes in management, plant, additional product and processing operations have to notify DVS prompt not later than 30 days after such changes.
5. The management of approved establishments are permitted to use the VHM logo only for the period as stated on the VHM Award Certificate.
6. For contract manufacturing of approved establishment for other organization or companies shall state name of approved manufacturer (manufactured by) and manufactured for (name of organization) on the packaging material. The logo shall be printed beside the name of the approved manufacturer.
7. Packing and repacking is only allowed for approved manufacturer and establishment.

Conditions for Withdrawal of VHM Logo

The above award can be withdrawn on the following conditions:

1. When major non-compliance is observed during surveillance and review audits.
2. When there is a change in the premise location as compared to the one approved at the time of award of VHM logo by the Department of Veterinary Services.
3. Changes in the company management not notified to the Department of Veterinary Services.
4. Changes in the operational system as compared to the one approved at the time of award by Department of Veterinary Services.
5. Voluntary withdrawal request from the program.
